



Terms and conditions of the Windward Islands Travel Photo Grand Prize

Article 1 : Object

Windward Islands Travel, SAS with a capital of 300 000 euros, registered at the RCS of Cannes under the number 807 393 772, (hereinafter "the Organizing Company") organizes a contest from October 5, 2021 to February 28, 2022 11:59 pm for the purpose of designating the best photograph on the theme of Water - Nature - Movement (hereinafter, the "Grand Prize"), according to the terms and conditions described in the present rules.

Article 2 : Conditions of participation

The contest is open to any natural person who has used Windward Islands Travel services, in particular as a renter, a boat buyer, a family member or a guest of the said renters or boat buyers.

Any participation of a minor will be automatically considered as having been made with the prior agreement of the persons holding parental authority and under the entire responsibility of the latter. The Organizing Body reserves the right to carry out any verification, in particular of identity and/or justification of parental authority, with the production of a written agreement justifying the parental agreement reached. Failure to produce all or part of the documents and/or information requested within the time limits set by the Organizing Body shall result, if applicable, in the disqualification of the Participant.

Members of the Organizing Body's staff and members of the Jury, as well as members of their families, are excluded.

Participation in the contest implies full acceptance of these rules, with no possibility of complaint as to the results.

Article 3: Duration of the contest and announcement of the Grand Prize

The contest is open from October 1, 2020 to February 28, 2022.

During the month of March 2022, a selection of the best photos will be published on the social network accounts (Instagram, Facebook, LinkedIn, Twitter) and the website of the Organizing Company. The winning photo of the Grand Prize will be announced and published on the same media in April 2022.

Article 4: Participation terms

Each participant may submit a maximum of 3 photographs in high definition format. The photo may be retouched, but it may not be edited using photo software. Participants are free to use their imagination to illustrate the theme.

The photos must be sent by email to info@windward-islands.net as an original file in JPG 300 dpi format, accompanied by the entry form duly completed.

The participants declare and guarantee that they are the authors of the proposed photos and consequently the exclusive owners of the corresponding intellectual property rights; they cede free of charge to the Organizing Body, for the whole world and for the duration of the copyright, the reproduction and representation rights relative to these photos which may be exhibited and/or published on any communication medium of the Organizing Body.

They also declare and guarantee that they have obtained the prior written authorization of the persons identifiable in the photos presented or of the persons who own the goods represented, which they must prove upon request by the Organizing Body. The Organizer shall in no case be held responsible for the use of said photos.

Article 5: Conditions of validity of the Photo

Each Photo is published under the sole responsibility of the Participant who undertakes to ensure that the said Photo is an original creation that does not infringe on the rights of third parties whatsoever and on any basis whatsoever.

Photos that do not meet these conditions and/or do not correspond to the theme set or photos with inappropriate content (in particular related to

violence, racism, pornography, and generally to good morals...) will be excluded from the contest.

The Participant undertakes to deal personally with any claim and/or proceedings, whatever their form, purpose or nature, brought against the Organizing Body and which are directly or indirectly related to the production and/or exploitation of his/her Photo and to indemnify it, including reasonable consulting fees.

The Organizing Body reserves the right to exclude from the competition any photo that is the subject of a complaint from a third party.

Article 6 Competition Jury and selection criteria

A jury is formed to select the best photographs, then among them, the winner.

Under the presidency of Lisa Salleron, it is composed of 4 members selected by Windward Islands.

The jury's mission is to select the photographs of the candidates presented in an anonymous way. No distinctive sign must be affixed to the photos. The names of the authors of the photographs will be known only to the persons in charge of receiving the works.

The photographs will be judged on three aspects:

- Relevance of the subject
- originality
- Technique and artistic interest.

The organizer reserves the right to invalidate or cancel all or part of an entry if it appears that fraud or malfunctions of any kind have occurred during participation in the contest.

The jury will select the Grand Prize winner from among the selected photos. The decision of the jury is sovereign and irrevocable.

Article 7 Prizes

The winner will receive a GoPro (HERO8 BLACK) with a total value of 400€ or a credit note on a cruise booked with WI Yachts, with a value of 500€.

Article 8 : Information to the Participants and how to obtain the prize

Within seven (7) calendar days following his designation by the jury, the winner will be contacted by email by the Organizing Company in order to inform him of the result of the contest and to ask him to exercise his choice between the GoPro or the credit note on a cruise mentioned in the 7 above. If the winner does not respond within twenty-one (21) days from the notification of the contest result, the winner will be deemed to have forfeited his/her prize which will then be awarded to the candidate ranked second by the jury. The above rules will apply to this new winner and so on, if necessary.

Article 9 Personal information

- Personal data

Participants must provide certain personal information about themselves: surname, first name, postal address, telephone number, e-mail.

- Person in charge of processing:

The personal data collected during the contest are intended for the Organizing Company which is responsible for their processing.

- Purpose of the processing of personal data:

This personal data is necessary for the determination of the winner, or successive winners if applicable, for the award and delivery of the prize.

This information is recorded and saved in a computer file. The servers hosting the information collected are those of the controller and are located in France.

- Duration of conservation:

The personal data concerning the participants will be kept for the duration of the Game and three months after its end for the provision of the prize. At the end of this period, the controller undertakes to delete all data.

- Participants' rights:

In accordance with Law No. 78- 17 of January 6, 1978 relating to data processing, files and freedoms as well as the European General Data Protection Regulation 2016/679 (RGPD), participants have a right of access, rectification, a right to erasure, a right to limitation of processing, a right to portability as well as a right to object to the processing of data concerning them.
